EMERGENCY ORDERS TO PROTECT THE HEALTH AND SAFETY OF THE RESIDENTS OF QUINHAGAK, ALASKA DURING THE COVID-19 PANDEMIC

The Native Village of Kwinhagak IRA Council, the City of Quinhagak Council and the Qanirtuuq Inc. Board of Directors met jointly to establish protocol effective March 23, 2020 until April 30, 2020 to ensure the health and safety of the residents of Quinhagak, Alaska during the COVID-19 pandemic and have established to following mandates:

- Air and land travel by non-residents (defined as having no residential ties to the community) into Quinhagak, Alaska is suspended until April 30, 2020, with the possibility for extension at a later date.
- Only emergency and essential public service personnel will be allowed entry into the community.
- Residents returning to Quinhagak will be required to follow a two-week mandatory self-quarantine.
- Residents must cease all non-essential travel out of the community and limit travel to essential travel for medical related or emergency purposes.
- Residents will follow the guidelines for COVID-19 issued by this Joint Emergency Order, the State of Alaska and the United States Government, and
- Residents will follow social distancing guidelines and are encouraged to cease all community gatherings and sleepovers.
- A 9:00 pm curfew for children and a 11:00 pm curfew for other residents is formally adopted.

The Native Village of Kwinhagak IRA Council, the City of Quinhagak Council and the Qanirtuuq Inc. Board of Directors puts the health and safety of its community residents as a priority above all else and desires to put precautions in place to prevent the entry and transmission of the COVID-19.

The Native Village of Kwinhagak IRA Council, the City of Quinhagak Council and the Qanirtuuq Inc. Board of Directors will put a priority on enforcement of this mandate to prevent the transmission of COVID-19 and failure to abide by the local, state and federal guidelines may result in criminal charges and fines.
