COUNT I:

That in the Fourth Judicial District, State of Alaska, on or about March 15, 2020,
at or near Quinhagak, JORDAN T. MARK intentionally caused the death of another

1 person, namely: I.A. (DOB: 06/29/2009).

2 All of which is an unclassified felony offense being contrary to and in violation
3 of 11.41.100(a)(1) and against the peace and dignity of the State of Alaska.

4 COUNT II:

5 That in the Fourth Judicial District, State of Alaska, on or about March 15, 2020,
6 at or near Quinhagak, JORDAN T. MARK, being 16 years of age or older, engaged in
7 sexual penetration with I.A. (DOB: 06/29/2009), a person who was under 13 years of age,
8 to-wit: JORDAN T. MARK inserted his penis inside I.A.'s vagina.

9 All of which is an unclassified felony offense being contrary to and in violation
10 of 11.41.434(a)(1) and against the peace and dignity of the State of Alaska.


11 COUNT III:

12 That in the Fourth Judicial District, State of Alaska, on or about March 15, 2020,
13 at or near Quinhagak, JORDAN T. MARK destroyed, mutilated, altered, suppressed,
14 concealed, or removed physical evidence with intent to impair its verity or availability in
15 an official proceeding or a criminal investigation.

16 All of which is a class C felony offense being contrary to and in violation of
17 11.56.610(a)(1) and against the peace and dignity of the State of Alaska.
