MARK, being 16 years of age or older, engaged in 6 sexual penetration with I.A. (DOB: 06/29/2009), a person who was under 13 years of age, 7 to-wit: JORDAN T. MARK inserted his penis inside I.A.'s vagina. 8 All of which is an unclassified felony offense being contrary to and in violation 9 of 11.41.434(a)(1) and against the peace and dignity of the State of Alaska. 10 COUNT III: 11 That in the Fourth Judicial District, State of Alaska, on or about March 15, 2020, at or near Quinhagak, JORDAN T.
