



Customers, partners, and employees: YKHC is here for you and your family. YKHC is making decisions related to COVID-19 based on guidance from the CDC, the State of Alaska and other experts. We are erring on the side of caution and in the best interests of our employees, customers and communities. YKHC is publishing a situational report to provide an update on our COVID-19 response and planning. Here is this week's report.

Testing Update

As of 3 p.m. March 12, YKHC has performed 75,385 tests —70,031 are negative and about 364 are pending. Three specimens were rejected by a private lab.

• YKHC offers free COVID-19 testing without an appointment at the Bethel drive-thru testing site. Testing hours are now every Monday-Friday from 2 to 4 p.m. Testing is also available by appointment in Bethel by calling 543-6949, or in villages by calling the local clinic.

Positive Case Count

- As of March 11, YKHC confirmed a total of 5,002 positive COVID-19 cases in the YK Delta.
 - 48 of these total cases were residents tested out-of-region or were not infectious while here, but per State reporting protocols, will be counted as YK Delta cases.
 - 52 of these total cases are non-residents, so per State reporting protocols, the official State YK Delta case count will remain at 4.902.

Vaccination Update

- As of March 12, YKHC has vaccinated 9,961 unique individuals throughout the YK Delta.
- For communities who have agreed to publish vaccination data, here are the percentages of eligible individuals who have received their vaccine:

Recoveries

- An individual who has been symptomatic is considered recovered when IO days have elapsed from when symptoms began, symptoms show improvement, and an additional 3 days have elapsed since their last fever.
- An individual who has been asymptomatic is considered recovered 10 days from their last test.
- Of the total 5,002 confirmed positives cases in the YK Delta, 4,895 cases are considered recovered, 82 remain active and 25 are deceased.

Situation Report

- For tests completed and returned between March 5 and March II there was a test positivity rate of x% in the YK Delta.
- To date, communities with evidence of community-based transmission of COVID-19 include: Akiak, Bethel, Chevak, Emmonak, Kongiganak, Kotlik, Kwethluk, Napaskiak, Quinhagak, Scammon Bay, Toksook Bay and Tuluksak.
- To preserve staff capacity and resources for on-going pandemic response, YKHC no longer publishes COVID-19 case statements on weekends or holidays. YKHC will publish case statements for weekends and holidays on the next business day. YKHC providers will continue to call and notify individuals of positive test results on





weekends and holidays.
